

# Notice and Affidavit Letter for Overseas Students Returning to Home Country during Academic Term/Summer Recess

## Chung Yuan Christian University

Dear fellow overseas students,

In response to the quarantine policy has been loosen by the CDC, CYCU held a meeting on 23 May, 2022 to discuss schemes for the entry quarantine measures for overseas student in the 2<sup>nd</sup> semester, Academic Year 2022. To reduce the risk of infection, please read the following important disease prevention regulations:

### **I. Policy of Entry Procedure for Overseas Students**

1. Based on the current policy, the COVID-19 RT-PCR report which shall be taken within 2-day prior to boarding. “Within 2-day period” will be calculated based on the “specimen collection date” instead of “test report date”, and additionally, it will pivot on the incoming flight’s scheduled departure time at the place of departure, that is, counting two calendar days backwards from the incoming flight’s scheduled departure time (excluding the flight date). For example, if the departure date is on Monday, the COVID-19 RT-PCR shall be taken on Wednesday.
2. Student **living off-campus** shall practice 7-day quarantine in the quarantine hotel and perform COVID test with antigen rapid test kit. After testing negative, the individual is required to continue practicing 7-day of self-health management.
3. Student **living on-campus** shall practice 7-day quarantine in the quarantine hotel and perform COVID test with antigen rapid test kit. After testing negative, the individual is required to continue practicing 7-day of self-health management in the dorm.
4. **Student who has not completed aforementioned quarantine measures is prohibited to access to the campus of CYCU, including the dormitory.**
5. Students should inform the place of residence during the period of self-health management. If you live with someone else, you must tell the person you live with that you are currently practicing self-health management.
6. **CYCU DOES NOT provide any subsidy to the medical and quarantine expenses incurred while staying overseas and after entering Taiwan by the current CYCU student.**
7. Quarantine policy is based on the announcement, which is made by the CDC. Amendments to the quarantine policy may be made in accordance with the situation of pandemic.

### **II. Relevant Regulations for Distance Learning Courses**

**For overseas students who fail to return to Taiwan before the new semester begins, CYCU will not offer any distance or online courses.**

### **III. Relevant Regulations for Taking Course While Abroad**

**Student going overseas during academic term shall reach consensus on the matter of how the courses will be given with the department office and the lecturers.**
